Sub: Revision Petition filed U/s 136 (3) of Karnataka Land Revenue Act 1964 against the order of Assistant Commissioner, Bhatkal in file No. RTS/AP/SR-39/2016-17 dated 16-03-2018.

Preamble:

The instant revision petition has been filed U/s 136 (3) of Karnataka Land Revenue Act 1964 against the order of Assistant Commissioner, Bhatkal in file No. RTS/AP/SR-39/2016-17 dated 08-03-2018.

Notices were issued to both the parties. Petitioners and respondents entered appearance through their counsel.

Brief facts of the case are as hereunder:

That M.E. No. 3/2014-15 based on judgement and decree in O.S. No. 280/1960 in respect of the properties bearing Sy.No. 1/1, 1/2, 1/3, 2/1, 2/2, 2/3, 2/4, 2/5, 2/6, 2/7, 2/8, 3/1, 3/2, 3/3, 3/4, 3/5, 3/6, 3/7, 22/1, 22/2, 22/3, 22/4, 22/5, 22/6, 22/7, 22/8 & 22/9 in the name of the petitioners was later cancelled by the Tahasildar on the basis of the objections filed by respondent No. 1 to 48. This order of Tahasildar was challenged by the petitioners before the Assistant Commissioner Bhatkal. But the appeal was dismissed by upholding the order of the Tahasildar.

Being aggrieved by the order of the Assistant Commissioner, the revision petitioner preferred revision petition before this Court on various grounds.

The Advocate for the petitioner argued that-

1. The impugned order passed by the Assistant Commissioner is contrary to law and true facts of the case.
2. The Assistant Commissioner has not appreciated the factual matrix in proper perspective.
3. The Assistant Commissioner ought to have allowed the appeal as the mutation entry was made on the basis of judgement and decree in O.S. No. 280/1960.

4. The Assistant Commissioner has failed to note that the revenue courts are bound to make entries based on the judgement and decree of Civil Court.

Hence on these among other grounds, the advocate for the revision petitioner requested to allow the revision petition in the interest of justice and equity.

The point for consideration before this Court is-

1. Whether there are sufficient grounds to interfere with the impugned order passed by the Assistant Commissioner Bhatkal?

Ans. In the Negative.

On perusal of the impugned order in the background of the documents on record, it is found that the disputed ME No. 3/2014-15 was entered based on the judgement and decree in O.S. No. 280/1960. Admittedly, the suit was for partition of immoveable properties. In such suits after passing preliminary decree, final decree proceedings should be initiated by the plaintiffs therein. But in the case on hand, there is nothing in the records to show about either final decree proceedings or execution of the decree. That being so, the Tahasildar is justified in cancelling the ME No. 03/2014-15 and Assistant Commissioner is further justified in dismissing the appeal. There are no valid grounds to allow the appeal. Hence, I proceed to pass the following order:

Revision petition is dismissed. The order dated 16-03-2018 passed by Assistant Commissioner Bhatkal is upheld.
